SUBJECT: Ordinance 17-07, Amendment to Chapter 14, Elections

BACKGROUND

As part of the budget discussions in July of 2016, Staff informed the City Commission that the last time the City's Code of Ordinances ("Code") had been reviewed was 20 years ago. Staff explained that included in the budget item entitled "contractual services" was the provision of funds for a review by Municode of the Code to ensure compliance with the Florida Statutes. Specifically, Municode's review was to identify obsolete provisions, conflicts and inconsistencies with the current state statutes, as well as any conflicts with other sections of the City's Code. The City Commission ultimately approved the budget, including contractual services, and subsequently, the City entered into a contract with Municode for the review of its Code. On February 22, 2017, Municode completed its review.

ANALYSIS / DISCUSSION

Municode ultimately recommended several changes to the City's Code. Specifically, with regard to Chapter 14, Municode found many code provisions were duplicates of either charter provisions or provisions in the Florida Statutes. At this point, the City Attorney recommends Chapter 14 of the City's Code be amended as provided in the attached draft ordinance. These revisions include the following changes to Chapter 14:

1. repealing Section 14-2 (provided in Charter),
2. deleting subsection (e) of Section 14-3 (obsolete),
3. repealing Section 14-4 (provided by Statute),
4. repealing Section 14-7 (provided by Statute),
5. deleting subsections (a) and (b) of Section 14-8 (provided in Charter), and
6. repealing Section 14-14 (provided in Charter).

RECOMMENDATIONS

The City Attorney recommends City Commission ultimately adopt draft Ordinance No. 17-07, Amendment to Chapter 14 - Elections.

ORDINANCE NO. 17-07

AN ORDINANCE OF THE CITY OF TREASURE ISLAND, FLORIDA, AMENDING THE CITY OF TREASURE ISLAND'S CODE OF ORDINANCES BY REPEALING SECTION 14-2 "ELECTION OF COMMISSIONERS BY DISTRICTS; MAYOR-COMMISSIONER AT LARGE"; AMENDING SECTION 14-3 "GENERAL AND SPECIAL ELECTIONS" TO DELETE SPECIFICATION OF THE 2016 ELECTIONS DATE; REPEALING SECTION 14-4 "POLLS"; REPEALING SECTION 14-7 "RESIGNING TO RUN FOR ANOTHER OFFICE"; AMENDING SECTION 14-8 "TERMS" TO DELETE PROVISIONS RELATING TO COMMISSION AND MAYOR TERMS ALREADY DEFINED IN THE CITY CHARTER; REPEALING SECTION 14-14 "VOTING PROCEDURE, CANDIDATES RECEIVING GREATEST VOTE ELECTED"; PROVIDING FOR SEVERABILITY; CONFLICT; CODIFICATION; AND AN EFFECTIVE DATE.

WHEREAS, on or about February 22, 2017, Municode conducted a legal analysis of the Code of Ordinances of the City of Treasure Island identifying redundant, conflicting or obsolete provisions; and

WHEREAS, the City desires that Section 14-2 of the City's Code of Ordinances be repealed so as to remove any redundant provisions in connection with the City Charter, as it is covered by the City's Charter §3.03; and

WHEREAS, the City desires to delete subsection (e) of Section 14-3 of the City's Code of Ordinances as it is an obsolete provision; and

WHEREAS, the City desires that Section 14-4 of the City's Code of Ordinances be repealed as it is covered by Florida Statutes §100.011; and

WHEREAS, the City desires that Section 14-7 of the City's Code of Ordinances be repealed as it is covered by Florida Statutes §99.012; and

WHEREAS, the City desires that Section 14-8, subsections (a) and (b) of the City's Code of Ordinances be deleted so as to remove any redundant provisions in connection with the City Charter, as it is covered by the City's Charter §3.03; and

WHEREAS, the City desires that Section 14-14 of the City's Code of Ordinances be repealed so as to remove any redundant provisions in connection with the City Charter, as it is covered by the City's Charter §5.04.

NOW, THEREFORE, THE CITY OF TREASURE ISLAND DOES ORDAIN:

SECTION 1. Section 14-2, "Election of commissioners by districts; mayor-commissioner at large" of the City of Treasure Island's Code of Ordinances, is hereby repealed from the Code of Ordinances as follows:

~~Sec. 14-2. – Election of commissioners by districts; mayor-commissioner at large.~~

~~— One city commissioner shall be elected from each district of the city by the qualified electors residing in such district. The mayor-commissioner shall be elected at large by the qualified electors of the city.~~

SECTION 2. Section 14-3, "General and special elections", subsection (e), of the City of Treasure Island's Code of Ordinances, is hereby amended as follows:

Sec. 14-3. – General special elections.

- (a) Regular and general municipal elections shall be held on the second Tuesday in March, unless the supervisor of elections requires the date to be changed pursuant to F.S. § 100.3605(2).
- (b) Reserved.
- (c) All other municipal elections that may be held shall be known as special municipal elections, and such elections may be called by the city commission at any time for such purposes as are authorized by the Charter and by the laws and the constitution of the state.
- (d) No general or special election of the city shall be held on a legal holiday.
- ~~(e) The date of the 2016 municipal election will be changed as required by the supervisor of elections, pursuant to F.S. §100.3605(2).~~

SECTION 3. Section 14-4, "Polls" of the City of Treasure Island's Code of Ordinances, is hereby repealed from the Code of Ordinances as follows:

~~Sec. 14-4. – Polls.~~

~~— The city commission shall designate the places of polling for the city elections, and the polls shall be open as such polling places from 7:00 a.m. to 7:00 p.m.~~

SECTION 4. Section 14-7, "Resigning to run for another office," of the City of Treasure Island's Code of Ordinances, is hereby repealed from the Code of Ordinances as follows:

~~Sec. 14-7. – Resigning to run for another office.~~

~~Any individual resigning to run for another office shall comply with the general laws of the state.~~

SECTION 5. Section 14-8, “Terms,” of the City of Treasure Island’s Code of Ordinances, is hereby amended as follows:

Sec. 14-8. – Terms.

~~(a) The city commissioners from districts 1 and 3 shall be elected in odd-numbered years and shall be elected for terms of two years. City commissioners from districts 2 and 4 shall be elected in even-numbered years and shall be elected for terms of two years.~~

~~(b) Commencing with the regular general municipal election held on March 4, 1997, the mayor shall be elected for a term of three years.~~

~~(c)~~ (a) All candidates offering themselves for election to an office of the city commissioner shall indicate the district in which they reside and all candidates for the office of mayor-commissioner shall so announce the office being sought and the district in which he resides; and the ballots shall be so arranged that the voters of the entire city may vote for the mayor-commissioner, but the voters of each district shall vote separately for the candidates of their own district commissioner.

SECTION 6. Section 14-14, “Voting procedure; candidates receiving greatest vote elected,” of the City of Treasure Island’s Code of Ordinances, is hereby repealed from the Code of Ordinances as follows:

~~Sec. 14-14. – Voting procedure; candidates receiving greatest vote elected.~~

~~The qualified electors of each district shall vote for one candidate for office of commissioner from their district; and when the office of mayor-commissioner is to be filled, they shall also vote for one candidate at large for mayor-commissioner. Any candidate in each district receiving a majority of votes of all the electors of the district shall be elected commissioner. Any candidate receiving a majority of votes of all the electors of the city shall be elected mayor-commissioner. If no candidate receives a majority of the votes cast, a runoff election shall be held on the second Tuesday following the date of the general or special election.~~

SECTION 7. SEVERABILITY. It is declared to be the intent of the City Commission that, if any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 8. CONFLICT. This action supersedes all codes and ordinances of the City or parts of, in conflict with this ordinance, to the extent of the conflict.

SECTION 9. CODIFICATION. Sections 1, 2, 3, 4, 5, and 6 of this Ordinance shall be codified in the Code of Ordinances for the City of Treasure Island, Florida. The codifier is authorized to renumber or reclassify such other provision of the Code of Ordinance to accomplish such intention. The codifier is also authorized to make editorial changes not affecting the substance of this Ordinance in the substitution of article, ordinance, section, paragraph, or such other appropriate word or phrase in order to accomplish such intention.

SECTION 10. EFFECTIVE DATE. This Ordinance shall take effect immediately upon its final passage.
